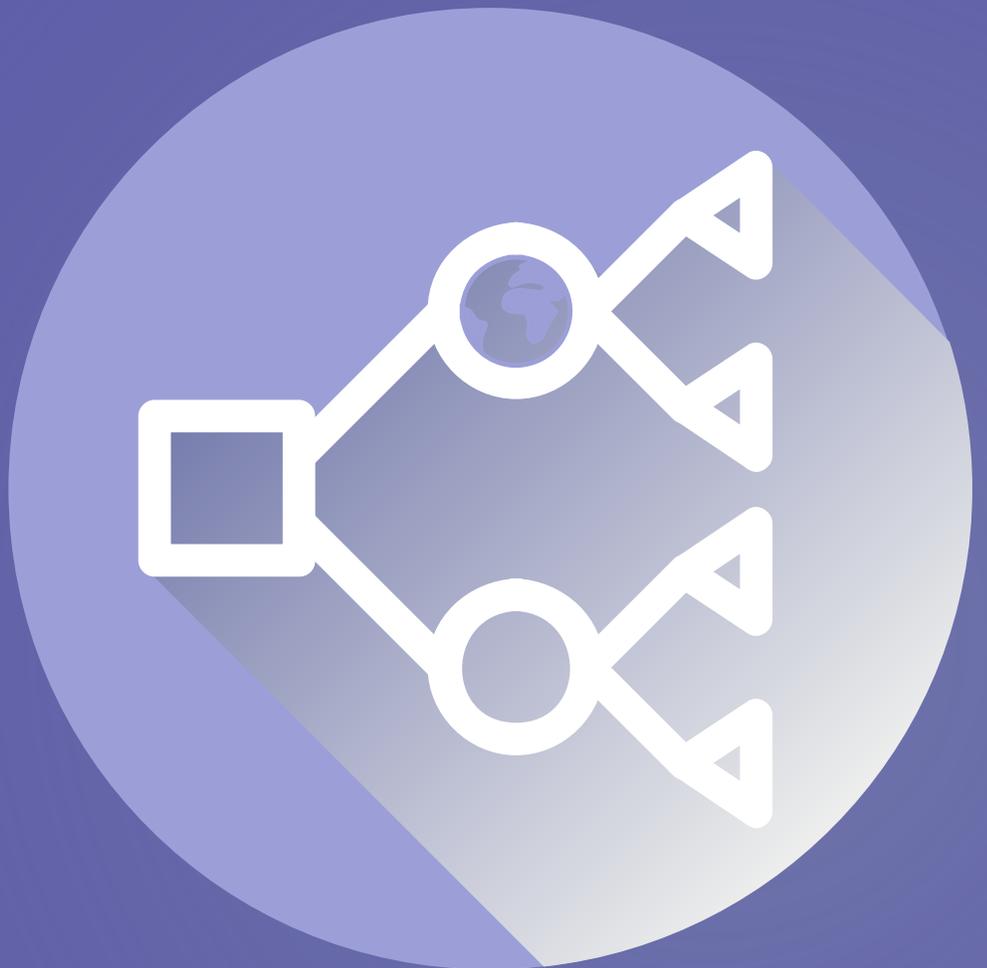


The journal Judgment and Decision Making, which I started in 2006, is now being produced by Cambridge University Press. Before this year, I was doing the production, but that is not a sustainable solution. “Production” means translating something in Word or in (often) very idiosyncratic LaTeX into a standard form, and doing copy editing. Cambridge will do much more than that; they will also handle announcements about the journal, archiving, and so on.

So far things are going reasonably well. New submissions are coming in, articles are being reviewed. As usual, some reviewers need reminding, and they will get it. But things are not finished. As yet, no article has actually made it to the stage of publication, although I hope that happens soon. And parts of the new web site are not working yet.

For now, information about what is available is included in <https://journal.sjdm.org>. This includes links to the submission system. Cambridge wants to maintain the journal as open-access, web only, and, to a first approximation, free to authors. One change is that articles will be published as they are ready, without “issues”.

The “free to authors” part will require some authors to request waivers from article processing charges, and, in theory, these requests could be rejected, although that has not happened so far. The main source of money for the journal apparently consists of “read-and-publish” agreements with university libraries. The list of these is quite long. Cambridge seems to be way ahead of other publishers on being able to support a journal like JDM. You might be able to nag your library to join, if they haven’t. (This is my idea. I have not been put up to it.)

You can choose how often you want to be notified (every article, weekly, monthly). It seems that you have to create an “account” in order to do this. So far as I know, it is harmless.

I have not decided what to do about the mailing lists, possibly a summary every month or two. Certainly not every article.

*A few months after the above, Jon Baron (jonathanbaron7 at gmail.com) writes:*

The first four articles of [the journal Judgment and Decision Making] 2023 are now published. More are in the pipeline. In the past I posted to these mailing lists when a new issue appeared. We have now abolished issues; articles will appear as they are ready. I have not decided whether to continue these periodic posts to mailing lists. If you go to the journal's page, you should find several ways to get alerts (upper right):

All articles published before 2023 are also available in the new site, with new formatting replacing the html versions. Data and materials are included as supplements. The original site (2006-2022) is preserved and available at [sjdm.org/journal](http://sjdm.org/journal) rather than [journal.sjdm.org](http://journal.sjdm.org). Links to [journal.sjdm.org](http://journal.sjdm.org) are now redirected to the new site, except for the statistical guidelines and for direct links to data, code, materials or other supplements (all of which redirect to [sjdm.org/journal](http://sjdm.org/journal)).

Article submission and processing should be more like that of other journals. Authors need to read the instructions with some care. Delays resulting from human error at our end (e.g., submitted articles falling through the cracks) should be reduced by the use of automatic reminders and nags. Authors and reviewers will get them too.

Cambridge University Press has done a remarkable job taking on this journal while preserving all its features, at least to close approximation. The usual indexing of articles will be preserved and somewhat expanded; Google Scholar already finds articles there. It is still open-access, and very few authors, if any, will need to pay publication charges.

(Cambridge is a nonprofit. It will not depend on author charges for income. It does depend heavily on read-and-publish agreements, so those in universities could see if their libraries are signed up.)

**Visiting Scholars Fellowship for Academic Year 2024-2025 Application Deadline: June 27, 2023 (11:59 PM EST)**

The [Visiting Scholars Program](#) provides a unique opportunity for select scholars in the social, economic, political and behavioral sciences to pursue their research and writing while in residence at the foundation in New York City. The fellowship period is September 1st through June 30th.

The foundation annually awards up to 17 residential fellowships. Visiting Scholars must be at least two years beyond the Ph.D. at the time of application and once selected, typically work on projects related to the foundation's [core programs](#) and [special initiatives](#). Scholars are provided with an office at the foundation, computers and software, library access, and supplemental salary support. Scholars from outside NYC are provided with a partially-subsidized apartment near RSF.

**Visiting Researcher and Visiting Journalist Fellowships: September 2023 - June 2024 (up to a 5-month visit) Application Deadline: May 2, 2023**

On an occasional basis, the Russell Sage Foundation (RSF) has available office space for short-term [Visiting Researchers](#) conducting research relevant to RSF's core programs <https://www.russellsage.org/programs> and [special initiatives](#). These positions do not come with any financial support and are available for visits up to five months, between September 1 and June 30, as space permits. Visiting Researchers are provided with an office at the foundation, computers and software, and library access. Applicants from outside the greater NYC area may be provided with a partially-subsidized apartment near RSF, if available. Visiting

Researchers must be several years beyond the PhD and have a project that is relevant to the Foundation's program areas.

Also, because journalists report on issues of relevance to RSF, the Foundation has established a [Visiting Journalist Fellowship](#). The fellowship provides journalists the time and resources needed to carry out an original project while also offering an opportunity to interact with resident visiting scholars who might help inform the development of these projects. RSF will pay visiting journalists a stipend of \$8,000 per month for full-time visits of up to four months (maximum stipend of \$32,000 per individual fellowship). Fellows are provided with an office at the Foundation, computers and software, and library access. Applicants who reside outside of the greater New York City area may be provided with a partially-subsidized apartment near RSF, if available. Eligible applicants should be journalists with a minimum of 5-7 years of experience who write or report on social, economic, or political conditions in the United States.

The Russell Sage Foundation was established by Mrs. Margaret Olivia Sage in 1907 for “the improvement of social and living conditions in the United States.” The foundation now focuses exclusively on supporting social science research in its core programs as a means of examining social issues and improving policies. Grants are available for research assistance, data acquisition, data analysis, and investigator time for conducting research and writing up results.

A detailed letter of inquiry must precede a full proposal. About 15% of investigators who submit LOIs are invited based on external reviews to submit proposals.

RSF has launched a new [pipeline grants competition](#) for early-career researchers in collaboration with the Economic Mobility and Opportunity program at the Bill and Melinda Gates Foundation. The next deadline for applications is November 1, 2023.

The competition seeks to promote diversity in the social sciences broadly, including racial, ethnic, gender, disciplinary, institutional, and geographic diversity. Early-career faculty who have not previously received support from RSF in the form of a Trustee or Presidential research grant or a visiting fellowship from RSF are eligible to apply.

### **Summer Institute in Migration Research Methods (SIMRM, June 7 - 15, 2023, University of California, Berkeley, Deadline: March 1st, 2023)**

The Summer Institute in Migration Research Methods helps to train early career researchers in best-practices and in methodologies particularly relevant to the study of immigration and migrant populations. The 2022 program will focus on: (1) conceptualizing, measuring and imputing legal status in migration studies; (2) studying immigration through social media and computational analysis; and (3) current frontiers in research on migration and health. The institute will also include sessions on research ethics and professionalization.

Participation is restricted to Ph.D. students, postdoctoral researchers, and untenured faculty within 5 years of receiving their Ph.D. who do empirical research on migration. It is open to researchers in the social sciences, professional schools (e.g., Education, Public Policy), or digital humanities who have sufficient training and background to succeed.

Call for Papers - Special Issue of Experimental Economics in memory of Amnon Rapoport

On December 6, 2022, we lost a giant in the field of experimental economics. Professor Amnon Rapoport passed away at his home in Tucson, Arizona.

It is our great pleasure to announce a special issue of Experimental Economics in memory of Professor Rapoport's contributions to the field of experimental economics. We are soliciting submissions related to Amnon's work on topics such as coalition formation, bargaining, social dilemmas, behavioral operations management, queues, behavioral game theory, dynamic pricing, and behavior in directed networks, as well as individual decision making. We are specifically interested in contributions that clarify the conditions under which the rationality assumption provides useful prediction of human behavior.

Professor Rapoport was one of the pioneers of the experimental study and quantitative modeling of human decisions in interactive contexts. During his distinguished career, he published multiple books, edited volumes, and more than 300 peer-reviewed research papers and chapters in leading psychological, management, operation, marketing, decision theory, economics, and political science journals, and is recognized as a leading authority in many of these areas.

Professor Rapoport's work focused on clarifying the conditions under which the rationality assumption provides useful predictions of behavior. It was theory-driven, and, in most cases, the theory was represented formally by mathematical (primarily, but not exclusively, game theoretical) models. He was a meticulous and rigorous, yet imaginative and creative, experimentalist, and was one of the first researchers to employ computerized experimentation to study individual and group decision making.

The deadline for submission is September 1, 2023, and our goal is to have the issue published in 2024. Please indicate in your cover letter that you are submitting for this special issue.

All submitted papers will be refereed by the usual EE standards and procedures. Should you have any questions please rami.zwick at ucr.edu

I am glad to announce that I will teach a summer school on open science in Innsbruck, Austria, this year. The summer school will be held on-site at the University of Innsbruck from July 3-7 2023, and will give 5 ECTS-credits. The program aims at providing a critical view on the “rules of a game named science,” and provides an introduction to remedies to the manifold issues jeopardizing the credibility of scientific results: power calculations, confirmatory research (pre-registration), and open and transparent research practices.

PhD Students and PostDocs from all disciplines are welcome to apply and will gain an understanding of common (mal)practices in scholarly research; learn to recognize the merits confirmatory and transparent research practices; gain a thorough understanding of error rates, significance, power, etc; learn how to undertake a priori power calculations and sensitivity analysis; be able to critically assess scientific processes and findings.

Postdoc at Princeton in intertemporal choice in politics

Applications are sought for a postdoc to start this fall on an ongoing project with Prof. Markus Prior on intertemporal choice in politics. The position is housed in the Center for the Study of Democratic Politics, a program in the School of Public and International Affairs at Princeton University.

Prof. Angela Yu has recently joined TU Darmstadt. Immediately available, and for the foreseeable future, are multiple positions for Postdocs and other positions.

Prof. Yu's group conducts research at the intersection of natural and artificial intelligence. Her group uses mathematically rigorous and algorithmically diverse tools to understand the nature of representation and computations that give rise to intelligent behavior, with particular regard to the challenges posed by inferential uncertainty and the opportunities afforded by volitional movement. Using diverse machine learning and statistical tools, e.g. Bayesian statistical modeling, control theory, reinforcement learning, and information theory, theoretical frameworks and mathematical models are developed to explain various aspects of cognition important for intelligence: perception, attention, decision-making, learning, cognitive control, active sensing, economic behavior, and social interactions.

Positions are available immediately, and will remain open until filled. Salaries are commensurate with experience and expertise, and highly competitive with U.S. and European standards. Written and spoken fluency in English is required. Fluency in German is not.
