The J/DM Newsletter welcomes submissions from individuals and groups. However, we do not publish substantive papers. Book reviews will be published. If you are interested in reviewing books and related materials, please write to the editor.

There are few ground rules for submissions. The best way to send your contribution is via EMAIL or in an ASCII file on a 3.5" or 5.25" diskette. If you must send hard-copy (e.g., if you are using special graphics or do not have computer access), please submit camera-ready copy. This means that the copy should be typed single-spaced on white 8½ by 11 paper. If possible, use a carbon or film ribbon. Please mail flat -- do not fold.

<u>Subscriptions</u>: Subscriptions are available on a calendar year basis only. Requests for information concerning membership in the Society for Judgment and Decision Making should be sent to Irwin Levin.

Address corrections: Please check your mailing label carefully. Because the *J/DM Newsletter* is usually sent by bulk mail, copies with incorrect addresses or which are otherwise undeliverable are neither forwarded nor returned. Therefore, we have no way of knowing if copies are delivered. Address changes or corrections should be sent to Irwin Levin.

Mailing Labels: Some readers may wish to send reprint lists or other material to people listed in the directory. Contact Irwin Levin for details.

Foreign Air Mail: Newsletters to non-US addresses are normally sent as printed matter air mail. Help Revise the Reader!

We are currently undertaking a revision of "The Reader", (aka Arkes & Hammond, (Eds.), <u>Judgment and Decision Making: An Interdisciplinary Reader</u>, Cambridge, 1986). Though this collection has served many of us well in introductory survey courses for seniors and beginning graduate students, it is now approaching its tenth birthday, and many of the papers it contains are showing signs of age. We solicit your ideas as to how it might be most usefully revised.

Comments and suggestions of all kinds are welcome, but we especially seek your thoughts on topics or specific papers (your own included!) you see as (a) candidates for addition, (b) candidates for removal, and (c) candidates for replacement or updating. (Citations are fine, if they are to commonly accessible journals or books, though actual reprints would be especially welcome!) We would also value any thoughts you may have on issues such as balance between theory and application, between classics and recent work, between specific results and reviews, and between depth in topics previously represented and topics that should be added. Obviously, with so many difficult balances to be struck, we cannot guarantee that we will act on every suggestion, but we will certainly consider each carefully. You might also wish to consider, in framing your suggestions, that Bill Goldstein and Robin Hogarth are putting together another reader for the series, sampling more advanced and more theory-oriented papers. We aim to connect with, but not to overlap, this volume.

As you may know, The Reader was the first fruit of the collaboration between the JDM Society and Cambridge University Press. Hal and Ken generously agreed to donate their royalties to the Society, and we intend to continue this practice. The Reader is thus something of a collective property of the Society; we invite you to contribute to its refurbishment.

Please let us hear your ideas.

From the President

Colleagues:

Much of the judgment and decision literature is published in authored or edited books. My impression is that, for various reasons, this mode of publishing is becoming increasingly popular. One problem this poses is that books and book chapters are harder for researchers to find than are journal articles. For instance, I have never seen an index for book chapters, and publishers have told me that no such index exists. This limited accessibility is hard on both readers and authors. Readers miss the opportunity to learn from scholarship that could advance their own work. (I have often stumbled on highly insightful book chapters solely by chance, and have been left wondering how many equally good chapters I have missed.) And many chapter authors are disappointed that their contributions enjoy less visibility than they should.

I am delighted to announce that, to address this access problem, the Society is offering a new initiative, an electronic "SJDM Book and Chapter Index." Alan Cooke and Alan Schwartz at Berkeley have generously volunteered to manage the network aspects of this new service. Paul Price of Michigan has been kind enough to serve as the moderator or "editor" of the index. In the next Newsletter, Paul, Alan, and Alan will give you details about how you can use the index as well as contribute entries. (We anticipate that the SJDM membership will be a major source of the items that will comprise the index.) In its essentials, however, the index will work much the way typical journal indexes do, e.g., the American Psychological Association's PsychINFO, except that you will be able to gain access to it via regular electronic mail connections. That is, the index will describe authored and edited books about all aspects of judgment and decision behavior. This includes books produced by standard publishing houses as well as conference proceedings and book-length technical reports. The index will also list judgment and decision chapters, not only from books devoted to our field exclusively, but to more general topics as well, e.g., cognitive psychology, artificial intelligence, or behavioral economics. Besides citations, listings will include brief abstracts, access information (e.g., persons to contact for copies of proceedings and technical reports), and keywords that can be used for searches.

I am very excited about this new index. There is every reason to expect that, in its own small way, the SJDM Book and Chapter Index will prove to be a significant tool in efforts to advance our understanding of judgment and decision behavior.

Electronic Mailing Lists

Response to the electronic mailing lists set up last month has been tremendous. There are currently 83 subscribers to the JDM-SOCIETY mailing list, and another 56 subscribers to the JDM-GRADS mailing list. Both lists have received a fair amount of traffic, and after fixing a few bugs, both are now serving as an easy means of communicating hot results and burning questions. These mailing lists allow a person to send e-mail to all of the current subscribers of the list with just one e-mail message.

There are two different mailing lists: One is for graduate students interested in J/DM named

jdm-grads@mellers1.psych.berkeley.edu

and one is for the members of the society in general, named

jdm-society@mellers1.psych.berkeley.edu

Graduate students interested in receiving J/DM e-mail should subscribe to the first list. All other people interested in receiving Society e-mail should subscribe to the second list.

Subscribing is easy. Just send e-mail to the following address:

listproc@mellers 1.psych.berkeley.edu

The e-mail does not need to have a subject. It only needs to have the following line somewhere in the body of the message:

subscribe mailing-list YOUR FULL NAME

where *mailing-list* is either **jdm-society** or **jdm-grads**, depending on the list to which you are subscribing. Subscription occurs automatically and will be verified by an e-mail welcoming you to the list and telling you how to do additional mailing list functions. To cancel your subscription to the list, send to list functions. To cancel your subscription to the list, send to list functions. To cancel your

unsubscribe mailing-list YOUR FULL NAME

You need not contact us unless you have questions or problems.

It is easy to send mail to each other. Just send the e-mail that you want posted to the relevant mailing list. (You need not be subscribed to the list to send mail to it.) It will automatically be sent to all current subscribers of the list. The list JDM-GRADS is a sublist of the JDM-SOCIETY mailing list, so grads will receive all society mailings. If a message is posted to JDM-GRADS, however, only the subscribers to JDM-GRADS will receive the mailing.

One note of caution: People replying to mail sent through the mailing lists should be careful to reply in the appropriate manner. Replies may be sent to either the original sender only, or to all members of the list. Please be careful when replying to list mail, and make certain that your reply will be sent to the appropriate recipients. Initially, there was a bug in the setup of the mailing lists such that all replies were sent to all of the list subscribers. This problem has been fixed. Here is a list of how some of the more popular mail programs work:

elm: Press 'r' to reply to the sender, 'g' to reply to the group

pine: Press 'r' to reply. The program will prompt you as to whether you want to reply

to all recipients.

UNIX Mail: Press 'r' to reply to the sender, and 'R' (upper-case r) to reply to the group.

CMS Mail: Edit the "To:" line to send to either the sender or the mailing list.

If you have questions, or your preferred mail program is not included in this list, contact your local systems administrator.

Internet Subject Cooperative

Following a proposal by Gerhard Holt and after some discussion over the electronic mailing list, I have volunteered to moderate an Internet Subject Cooperative. The idea is for researchers to fill out each other's questionnaires and surveys, for pilot studies or real data. Initially, it will be for members of the JDM list. In explaining how it works, I will speak of "members" of the cooperative group. Each member is a subject and a researcher.

- 1. Members will send questionnaires to me by email. If the questionnaire has more than one form, I will divide up the forms among the members without bias. (I will keep the list in order of volunteering, then allocate forms alternately, occasionally rearranging the list haphazardly.) I will send the questionnaires to the members by email.
- 2. Questionnaires should be returned to their designers, not to me (although I will deal with errors). Thus, I will not keep track of who responds, and I will require that a RETURN ADDRESS be included in each questionnaire. This is the largest departure from Gerhard's original idea, but anything else is just too much work for me. I hope that the cooperative spirit will keep the thing going without explicit enforcement. I can monitor general compliance if you tell me how many responses you get.

- 3. I will keep the list of members just as a simple list of addresses. Thus, I cannot deal with notes like "in August, I can be reached only at clavius@moon.mil."
- 4. This list will be confidential, EXCEPT that I do not promise to keep it forever, and I will turn it over to anyone who wants to take over as moderator (especially if they are able to improve on my methods), and:
- 5. If this plan is at all successful, I may want to expand it by joining together with other groups aside from JDM members, e.g., readers of sci.psychology.research, or readers of such local newsgroups as upenn.psych.general. I will send notices of such mergers either to the jdm list or to all the members, but I will not wait forever for people to object and ask that their names be removed. I assume that there will be few such objections anyway. (Conversely, if the plan fails, e.g., because only 5 people volunteer by the end of June, or if it is too much work, I will notify the members that I am giving up.)
- 6. I ask that each questionnaire indicate at the beginning the NUMBER OF QUESTIONS. (I have found this to be helpful in reducing the number of missed items.) Members should feel obliged to fill out all short questionnaires, but their degree of felt obligation should fall off as the length increases. Questionnaires with different forms should ask respondents to IDENTIFY THE FORM in some way. Also, remember that something that looks like an ordinary printed questionnaire is not necessarily the easiest thing to fill out in emacs: for example, "____" for responses is pretty useless. (I put things in CAPS when an answer is required.) Finally, please include a DUE DATE.
- 7. I remind all members that questionnaires sent out on the Internet are usually subject to approval by institutional review boards for protecting human subjects. Members are responsible for securing such approval for their own studies. I will do it only for my own. I will also reserve the right to return questionnaires that seem to me to be inappropriate in some way, although I cannot now imagine what that would be. (Try not to think too hard about it.)

If you are interested, just send me a message saying so. No need for any particular format. All I will keep is your email address. If you send me a questionnaire and you are not on the list, that will get you on it. Let's hope this works. It will not only be a good source of data (at least for those, like me, who think that researchers are people too) but also a good way of starting discussions of research issues.
