There are few ground rules for submissions. The best way to send your contribution is via EMAIL or in an ASCII file on a 3.5" or 5.25" diskette. If you must send hard-copy (e.g., if you are using special graphics or do not have computer access), please submit camera-ready copy. This means that the copy should be typed singlespaced on white 8½ by 11 paper. If possible, use a carbon or film ribbon. Please mail flat -- do not fold.

Advertising Rates: Advertising can be submitted to the editor. Inclusion of the ad and the space given to the ad is at the editor's discretion. The current charge is \$75 per page to cover production and mailing costs. Contact Shawn Curley for details. Alternatively, you can use-

Symposium Deadline Extended

The program committee is seeking to increase the number and diversity of symposia at the annual meeting. Accordingly, we are extending the deadline for symposium proposals to AUGUST 16. We are interested in symposia on any JDM-related topic, but we especially encourage proposals in areas of applications. Instructions for submitting a symposium proposal are found on page 6 of the *Newsletter*. Also, any of the committee members will be happy to discuss symposium ideas with potential proposers--addresses are also given on page 6.

Submissions Invited for the Teaching Forum

The committee will again organize a session on the teaching of JDM topics. In addition to the poster and demonstration formats offered last year, we will also consider proposals for short (20-minute) presentation/demonstrations on teaching topics. The deadline for Teaching Forum submissions is **SEPTEMBER 1**. See the instructions on page 6 of the *Newsletter*.

Parallel Sessions

The JDM program this year will experiment with a limited number of parallel sessions, although the majority of the conference will retain the traditional single track format. The goal of this innovation is to permit a larger number and greater diversity of symposia and paper presentations.

Paper and Poster Submissions

Although the deadline for submissions for papers and posters has passed, the committee may be able to consider additional submissions received in the next couple of weeks, while final selections are being made. Submission instructions and forms are reproduced on pages 6 and 7 of the *Newsletter*.

Program Reminder

This year's program will follow the schedule used last year, with an initial social-and-poster session on Saturday evening and concluding mid-afternoon on Monday. Further details will be forthcoming in the next *Newsletter*.

SUBMISSIONS -- 1995 JDM ANNUAL MEETING

All submissions for SYMPOSIA will be considered if received by the extended deadline of AUGUST 16. Potential submitters are welcome to contact any of the committee members prior to that date to discuss ideas.

All submissions for the TEACHING FORUM will be will be considered if received by SEPTEMBER 1.

The deadline for INDIVIDUAL PAPERS and POSTERS has passed, but late submissions received in the next couple of weeks may be considered, while final selections are being made.

FOR ALL SUBMISSIONS: Please indicate at the top the type of submission (symposium, teaching forum contribution, individual paper, or poster), your name, address, phone, and e-mail address, and the title of your proposed contribution.

FOR SYMPOSIA: Symposia are usually allotted about 90 minutes each, and include 3 or 4 speakers and often a discussant. Submit a 100-200 word description of the intended theme and format of the session. Attach a list of intended participants, including their names, addresses, phone numbers, and e-mail addresses, and a brief description of the topic of each talk. Please confirm the speakers' willingness to participate prior to submitting their names.

FOR THE TEACHING FORUM: Submit a 100-word abstract of the topic, and indicate your preference for one of the three available formats: (a) Full (4 ft. x 8 ft.) poster; (b) half-poster; (c) 20-minute presentation/demonstration. Poster displays may also be accompanied by a demonstration; participants should plan to bring their own equipment.

FOR INDIVIDUAL PAPERS: Submit a one-page abstract of the paper. You may also include a copy of a completed paper, but need not.

FOR A POSTER: Use the application form on the following page. Note that at least one of the authors must be a member of the JDM Society.

I expect to be able to support a post-doctoral researcher for the year beginning September, 1995. The work would be on several research projects, considering issues of risk perception, risk communication, risk management, and the evaluation of environmental amenities. Most will have both basic and applied aspects. In addition to helping to fulfil the requirements of the contracts providing the funding, the person occupying the position would be encouraged to develop independent topics within the general project areas. Although I am the principal investigator on these projects, some involve other members of the department. All involve graduate students. There would, of course, be the opportunity to participate in the general life of the department and the university.


City University, London Centre for HCI Design, School of Informatics & Department of Psychology Research Assistant in Cognitive Science

Applications are invited for a research assistant to work on project CROM (Cognitive Route Modelling) of food risk perceptions sponsored by the UK Ministry of Agriculture, Fisheries and Food. The research will involve developing a cognitive theory of human risk perception building on attribution and process theories of judgement. A series of experiments are planned to validate the model and provide insights into human judgement. The theoretical model will be implemented as a prototype decision support system for forecasting public and expert reactions to reports of food risks. The post requires experience in experimental design and cognitive modelling and programming skills in expert system shells/tools are desirable. The post will be for 3 years on the IA research assistant scale according to experience and qualifications (13,941 to 20,953 [UK pounds] plus 2,134 London allowance).

Candidates should preferably have a PhD in cognitive science/psychology with research experience in the subject area of risk assessment, human judgement or cognitive modelling. Tips for Travelers to SPUDM - 15

How to get to the hotel: When you arrive at Ben Gurion airport, you will find outside the passenger terminal limousine service to Jerusalem. This service costs \$10 for a shared ride (dollars and shekels will be accepted), run by the Nesher company, or \$40 for a private limousine. Both will take you all the way to the hotel, but the shared ride drops off all passengers at their final Jerusalem destination, and you may be dropped off first, last, or in between. The fee is payable at the end of the ride and no tip is required.

How to get to the airport: The same service will take you, for the same price, from the hotel to the airport. Reservations should be made a day in advance (tel. 257-227). Travel time is 40-60 minutes.

Money: The local coin is the New Shekel--NS. Exchange rates for the past year or more have hovered close to 3NS per dollar. Most places will take dollars, however, and credit cards.

Shopping: Shops are typically open Sunday to Thursday from about 9 am to 7 pm, some closing between 1 pm and 4 pm. Friday is a half day--most places close about 2 pm. The official day of rest is Saturday, and Sunday is a regular weekday. There are no shops in the immediate vicinity of the hotel.

Weather: August in Jerusalem can be very hot, up to the high 30s C (about 100 F)--like southern California or southern Europe. More typical, however, are temperatures around 30 C (87 F). It never rains in Jerusalem in summer, indeed, the heat is dry. The evenings usually cool off considerably, sometimes even requiring a light coat. The hotel is fully air-conditioned, and has a swimming pool.

Clothing: Bring clothing for hot, dry days and cool evenings. For the tour to the Old City, modest dress is recommended to ease entrance into the holy sites.

Getting around Jerusalem: The hotel is a bit out of the way, though not far from the center. It operates a free, though infrequent, shuttle to the town center. Those wishing to go out on their own outside of the times that the conference will provide transportation (as for the organized tours included in the program) could take a taxi. Rides to the town center should run less than \$5, and tipping is not required. A map of Jerusalem is included in your conference packet.

Restaurants: Breakfast is included in the price of the room. Israeli hotel breakfasts are rather large, including a variety of cheeses, yoghurts, breads, and fresh vegetables, as well as items like eggs and cereal. Lunch will be provided in the hotel for extra pay, cafeteria style or at the hotel restaurant. You may want to go out for dinners. We will provide a list of Jerusalem restaurants. You can have a nice dinner for prices from \$15 up. The national snack food is falafel--a generous and quite filling portion can be had for less than \$2. Service charge in Israel is only 10% (though more is gladly accepted), and usually is not included in the bill.

Telephones: Jerusalem is full of card operated public phones. Cards are sold all over.

Service desk: Besides the hotel desk, the conference will operate its own service desk, including a Travex representative, where you can make various arrangements. Please note that the hotel does not provide conference facilities (computers, copying machines, and the like), so you should be prepared to come with all the materials you might need for your presentation.
