The Federation is a coalition of 17 scientific societies and approximately 150 affiliate members--university graduate departments, APA divisions and regional psychological associations.

NIH Office of Behavioral and Social Sciences Research

The reauthorization of NIH has passed through the legislature. Part of this bill establishes the Office of Behavioral and Social Sciences Research as of July 1, 1993. The legislation stipulates that "with respect to research on the relationship between human behavior and the development, treatment, and prevention of medical conditions, the Director of the Office shall: a) coordinate research conducted or supported by the agencies of the National Institutes of Health; and b) identify projects of behavioral and social sciences research that should be conducted or supported by the national research institutes, and develop such projects." The Director will serve full-time in carrying out the mission of the Office.

New Director of Social, Behavioral and Economic Research at NSF

Allan Kornberg, professor of political science at Duke University, has been named director of the Social, Behavioral and Economic (SBE) Research Division within the SBE directorate at NSF. Dr. Kornberg received his degree from the University of Michigan in 1964. He has taught at Duke since 1965, concentrating in areas of comparative political and legislative behavior and comparative party systems. A Canadian by birth, he has published extensively on American and Canadian political structures. From 1980-1983 he served as a member of the Political Science Advisory Panel at NSF and in 1987 was the chair of the Political Science Oversight Committee. Dr. Kornberg will assume his duties full time beginning in September. The directorship is a rotating position. It is expected that he will serve a term of approximately two years.

Publication

For those scientists new to the rigors of proposal writing and overwhelmed by the prospect of it, help is available. Soon to be released in its fourth edition, Syracuse University Press publishes How to Prepare a Research Proposal: Guidelines for Funding and Dissertations in the Social and Behavioral Sciences by David Krathwohl. Internet News

NSF, which has managed the Internet service to date, has been moving to turn over this responsibility to the private sector. Instead of all regional networks being connected to NSFNET, access to NSFNET will be restricted to supercomputer applications. Regional networks will be connected via a commercial system. Eight regional networks have already contracted with the MCI Communications Co. It is likely that the transition to a private enterprise will not cause noticeable interruption in the Internet.

On a related note, it is now possible to contact the President or Vice President of the US via their Internet addresses: cpresident@whitehouse.gov> and <vice.president@whitehouse.gov>.

The Federation has also moved to the Internet, and is no longer available through Bitnet. The address is: <federation@apa.org>. The Federation invites communications. To this end, they ask that you send your address to be included in their database.

Burnand B, Feinstein AR. The role of diagnostic inconsistency in changing rates of occurrence for coronary heart disease. J Clin Epidemiol. 1992;45:929-40. Shows how changing diagnostic accuracy can alter the accuracy of vital statistics data.

DEGNER LF, SLOAN JA. Decision making during serious illness: what role to patients really want to play? J Clin Epidemiol. 1992;45:941–50. Suggests that the impact of being diagnosed with a life-threatening illness can make people more interested in having the physicians make treatment decisions on their behalf.

DENEEF P, KENT DL. Using treatment-tradeoff preferences to select diagnostic strategies: linking the ROC curve to threshold analysis. Med Decis Making. 1993;13:126–32. Illustrates the linkage between operating point on a ROC curve and the preferred action derived from benefit-to-harm ratios.

DEYO RA, RAINVILLE J, KENT DL. What can the history and physical examination tell us about low back pain? JAMA. 1992;268:760-5. Identifies the usefulness of a good history and physical examination in the diagnosis and management of lower back pain.

ELSTEIN AS, KLEINMUNTZ B, RABINOWITZ M, et al. Diagnostic reasoning of high—and low—domain-knowledge clinicians: a reanalysis. Med Decis Making. 1993;13:21—9. Demonstrates how to evaluate the generalizability of results from protocolanalysis studies.

ERIKSEN S, KELLER LR. A multiattribute-utility-function approach to weighing the risks and benefits of pharmaceutical agents. Med Decis Making. 1993;13:118–25. Develops a method to combine the utilities for efficacy and toxicity data from human and animal sources.

FRYBACK D, DASBACH EJ, KLEIN R, et al. The Beaver Dam health outcomes study: initial catalog of health-state quality factors. Med Decis Making. 1993;13:89–102. Provides survey results that compare different methods of measuring a person's health status.

GUYATT G, CAIRNS J, CHURCHILL D, et al. Evidenced-based medicine. A new approach to teaching the practice of medicine. JAMA. 1992;268:2420–5. Suggests that clinicians should rely less on intuition and clinical experience and more on evidence from clinical research.

HAYS MV. On the epistemology of risk: language, logic and social science. Soc Sci Med. 1992;35:401-7. Questions the usefulness of the current usage of "risk" in the health care literature.

HOLTGRAVE DR, LAWLER F, SCHWIEBERT LP. Teaching clinical decision making in a family practice clerkship. Med Decis Making. 1993;13:114–7. Presents survey results that show that medical students regarded a unit on clinical dicision making as useful.

KIEBERT GM, STIGGELBOUT AM, LEER J-W, et al. Test-retest reliabilities of two treatment-preference instruments in measuring utilities. Med Decis Making. 1993;13:133-40. Found inconsistent reliabilities of different methods to measure utilities.

Krahn M, Detsky AS. Should Canada and the United States universally vaccinate infants against hepatitis B? Med Decis Making. 1993;13:4–20. Concludes that a policy of universal vaccination of infants against hepatitis is comparable in cost-effectiveness to existing health care interventions.

LENTZNER HR, PAMUK ER, RHODENHISER EP, et al. The quality of life in the year before death. Am J Public Health. 1992;82:1093–8. Develops a multidimensional index to estimate extremes in health status in elderly people prior to their death.

LIEBHART K, KRUSINSKA E. Classic versus sequential diagnostic support for chronic nonspecific respiratory diseases. Med Decis Making. 1993;13:103–13. Compares the diagnostic usefulness of a Bayes–Fisher linear discrimination with a decision-analytic linear discrimination.

MAZUR DJ, HICKMAN DHJ. Patients' and physicians' interpretations of graphic data displays. Med Decis Making. 1993;13:59–63. Reports on differences between patients' and physicians' interpretations of five-year survival curves.

McConnochie KM, Roghmann KJ, Pasternack J. Developing prediction rules and evaluating observation patterns using categorical clinical markers: Two complementary procedures. Med Decis Making 1993;13:49–58. Provides SAS macros to evaluate the validity of computerized predictions that are extrapolated to a new population.

MORENO HR, PLANT RT. A prototype decision support system for differential diagnosis of psychotic, mood, and organic mental disorders. Med Decis Making. 1993;13:43-8. Describes a decision aid for diagnosing psychological disorders.

NICHOL MB, McCOMBS JS, JOHNSON KA, et al. The effects of consultation on over-the-counter medication purchasing decisions. Med Care. 1992;30:989–1003. Identifies several factors that can predict changes in consumer decisions to purchase nonpresciption medications.

PEIRCE JC, CORNELL RG. Integrating stratum-specific likelihood ratios with the analysis of ROC curves. Med. Decis Making. 1993;13:141–51. Shows the benefits of deriving stratum-specific likelihood ratios as part of an ROC analysis.

STROBINO DM, FRANK R, OBERDORF MA. Development of an index of maternal transport. Med Decis Making. 1993;13:64–73. Uses decision analysis to develop an index for maternal transport.

TSEVAT J, GOODMAN L, SOUKUP JR, et al. Stability of time-tradeoff utilities in survivors of myocardial infarction. Med Decis Making. 1993;13:161–65. Concludes that changes in time-trade-off utilities did not correlate with changes in functional status.

Van Rulswyk J, Hartz A, Kuhn E, et al. A measure of mortality risk for elderly patients with acute myocardial infarction. Med Decis Making. 1993;13:152–60. Presents a scoring rule to predict risk of mortality in elderly patients with acute myocardial infarction.

RESEARCH CENTER

The Center for Rationality and Interactive Decision Theory was established as an interdisciplinary research center at the Hebrew University of Jerusalem in 1991. It is engaged in research into the various aspects of rationality in decision making: making decisions in a manner calculated to yield maximal benefit. Of particular interest is interactive decision theory ("game theory"), which analyzes what happens when rational people with different goals interact, each making his own decisions on the basis of what is best for him--while taking into account that the others are doing the same. Rationality and interactive decision theory underlie much of economic theory and have had an important impact on such diverse areas as evolutionary biology, political science, computer science, social psychology, law, statistics, philosophy and the foundations of mathematics.

The label date should indicate if you have done this. Members residing in countries where getting checks written in U.S. funds is impractical or illegal may apply to the Society for a free membership. Such members will find a "*" next to their names on the label.

NOTE!: Newsletters to non-US addresses are normally sent as printed matter air mail. For an additional \$10 per year, non-US subscribers can have the newsletters sent letter class air mail. To obtain this service, add \$10 for each year of dues and briefly note this on your dues form.
